

Website Terms of Use

Agreement between user and JPC IT Solutions

JPC Online Holdings, LLC's website domains – www.jpc-it.com and www.jpconlineholdings.com (the "Site") is comprised of various web pages operated by JPC Online Holdings LLC dba JPC IT Solutions ("JPC"). The Site is offered to you conditioned on your acceptance without modification of the terms, conditions, and notices contained herein (the "Terms").
